PERIOD OF TIME. SO THAT ■ MAY EARN THE
RIGHT TO RETURN BACK TO THIS COMMUNITY
AS AN UPSTANDING CONTRIBUTING MEMBER
OF THIS COMMUNITY. PRIOR TO MY INCARCERA-
TION I DID NOT KNOW THAT SUCH OPPORTUN-
ITY EXISTED. AFTER LEARNING THAT SUCH OPPORTUN-
RIGHT THAT IVE BEEN AFFORDED THE CONSTITUTIONAL
■ TO BE GRANTED A SECOND CHANCE IN WHICH
TO EXERCISE THOSE RIGHT AGAIN.
