## AN ACT REQUIRING AN INVESTIGATION OF THE EFFECTIVENESS OF THE DEPARTMENT OF BANKING.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. (*Effective from passage*) (a) The Banking Commissioner 2 shall conduct an investigation of the effectiveness of the Department of 3 Banking. In conducting such investigation, said commissioner may 4 employ such consultants and experts as the commissioner deems 5 necessary.

6 (b) Not later than January 1, 2007, said commissioner shall submit a 7 report that shall include findings and recommendations to the joint 8 standing committee of the General Assembly having cognizance of 9 matters relating to banks, in accordance with section 11-4a of the 10 general statutes.

The bill requires the banking commissioner to investigate the effectiveness of the Department of Banking and to submit a report to the Banks Committee by January 1, 2007.
