

Explanation

The bill eliminates the Norfolk probate court and creates the new probate district of the Northwest Corner, consisting of the towns of Canaan, Cornwall, Norfolk, North Canaan, Salisbury, and Sharon. The reorganization results in a savings by eliminating expenses of the Norfolk probate court, which are approximately \$30,000.

SB 457

AN ACT CONCERNING THE CONSOLIDATION OF THE NORFOLK PROBATE DISTRICT INTO THE NORTHWEST CORNER PROBATE DISTRICT.

SUMMARY:

This bill eliminates the probate district of Norfolk, consisting of the town of Norfolk. It adds Norfolk to the Northwest Corner Probate District, which currently consists of Canaan, Cornwell, North Canaan, Salisbury, and Sharon. (PA 04-19 creates the Northwest Corner Probate District effective January 3, 2007.)

The bill requires a judge to be elected for the Northwest Corner Probate District, which includes Norfolk, in 2006 and every four years thereafter. Beginning January 3, 2007, the bill gives the probate court for the Northwest Corner Probate District, which includes Norfolk, jurisdiction over all probate business arising in Norfolk.

EFFECTIVE DATE: Upon passage, except for the provision eliminating the Norfolk district and adding Norfolk to the Northwest Corner district, which takes effect January 3, 2007.
