#### Explanation

Requiring the Commissioner of the Department of Economic and Community Development (DECD) to conduct a study of state economic development programs and recommend revisions on or before January 1, 2007 is anticipated to increase costs to DECD. It is estimated that the DECD would need to hire a consultant at an estimated cost of \$250,000. Since the scope of the study is not clearly defined, the exact cost of the study is unknown.

It is anticipated that the Connecticut Development Authority, Connecticut Innovations, Inc., and the Connecticut Housing Finance Authority could consult within their existing resources.

# AN ACT CONCERNING THE STUDY OF ECONOMIC DEVELOPMENT PROGRAMS.

#### SUMMARY:

The bill requires the economic and community development commissioner, in consultation with the Connecticut Development Authority, the Connecticut Housing Finance Authority, and Connecticut Innovations, Inc., to study and recommend revisions in state economic development programs to promote the state's economic competitiveness. The commissioner must also request comments from municipalities and regional economic development agencies in conducting the study. He must report the study to the Commerce Committee by January 1, 2007.
